### **5.1 Husky Energy Well Applications**

That the Council for the Town of Rainbow Lake offers no objections to the drilling of sour gas wells located at 5-34 and 2-35 within the Town limits of the Town of Rainbow Lake subject to the following conditions being met:

1. That Husky Energy ensures that the wells are tied into the pipeline system and not operated as single well batteries if the wells are to be used for production.
2. That Husky Energy uses established road access points contained in the Town of Rainbow Lake Transportation Master Plan to access the wells within the Town. All roads are to be constructed to Town standards including surfacing.
3. That an odor control plan be established for the wells during production testing.

4. That the Husky Energy establishes emergency procedures including, but not limited to, notification of the public in the event of an incident during drilling or production operations of the wells.
5. That Husky Energy conducts a practice emergency exercise prior to drilling the critical zones of the wells involving Town Of Rainbow Lake Emergency Personnel.
6. That Husky Energy provides a complete drilling plan for the Town of Rainbow Lake after the establishment of the wells within the Town boundaries.
7. That Husky Energy agrees to compensate (at fair market value) the Town of Rainbow Lake for any lands sterilized for commercial or residential development as a result of the location of the wells in the Town boundaries.
