Whereas, the Town of Rainbow Lake has prepared and adopted detailed estimates of the municipal revenues and expenditures as required, at the council meeting held on April 18, 2017; and

Whereas, the estimated municipal expenditures including requisitions and transfers set out in the budget for the Town of Rainbow Lake for 2017 total \$7,113,545; and

Whereas, the estimated municipal revenues and transfers from all sources other than taxation is estimated at \$5,956,002 and the balance of \$1,157,543 is to be raised by general municipal taxation; and
