

BYLAW TITLE:

2022 TAXATION BYLAW

PURPOSE:

A BYLAW TO AUTHORIZE THE RATES OF TAXATION LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE TOWN OF RAINBOW LAKE FOR THE 2022 TAXATION YEAR.

Whereas, the Town of Rainbow Lake has prepared and adopted detailed estimates of the municipal revenues and expenditures as required, at the council meeting held on April 21, 2022; and

Whereas, the estimated municipal expenditures including requisitions and transfers set out in the budget for the Town of Rainbow Lake for 2022 total \$6,707,190; and

Whereas, the estimated municipal revenues and transfers from all sources other than taxation is estimated at \$6,235,360 and the balance of \$471,830 is to be raised by general municipal taxation; and

Whereas, the requisitions are:

Whereas, the Council of the Town is required each year to levy on the assessed value of all property, tax rates sufficient to meet the estimated expenditures and the requisitions; and

Whereas, the assessed value of all property in the Town of Rainbow Lake as shown on the assessment roll is:

This bylaw shall be known as the "2022 Taxation Bylaw"

**GENERAL RULES
AND SPECIAL
PROVISIONS:**

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Town of Rainbow Lake:
