TOWN OF RAINBOW LAKE NOTICE OF RESOLUTION

Municipal Government Act Section 70 – Disposal of Land LOT A PLAN 782132

Rainbow Lake Town Council has received an offer to purchase lands owned by the Town of Rainbow Lake at less than fair market value. It is the intent of Rainbow Lake Town Council to accept this offer via resolution on February 1st, 2024, during the regularly scheduled Council Meeting.

Detailed information regarding the disposal of land can be obtained by contacting the Town Office at 65 imperial Drive, Rainbow Lake, AB, T0H 2Y0.

A Section 70 resolution is open to consideration via petition of residents of the Town of Rainbow Lake. A petition must be filed following section 219 of the Alberta Municipal Government Act, with the Interim CAO, Mark Kastiro at 65 Imperial Drive, Rainbow Lake, AB, T0H 2Y0 on or before March 7th, 2024 by 3:00pm.

Alberta Municipal Government Act Section 231 (4) and (5)

- (4) A petition under this section for a vote of the electors on a proposed bylaw or resolution required to be advertised by another Part of this Act or another enactment is not sufficient unless it is filed with the chief administrative officer within 60 days after the last date on which the proposed bylaw is advertised.
- (5) If a sufficient petition is received under this section, the council must either
 - (a) decide not to proceed with the proposed bylaw or resolution, or (b) decide to proceed with the proposed bylaw or resolution and submit the bylaw or resolution to a vote of the electors within 90 days after the chief administrative officer declares the petition to be sufficient.
